Mark Haas and David Hubbard stated that Lycoming County was redoing the Zoning Ordinance. Due to the way the township is zoned it does not allow for small home businesses in many areas of the township. The Proctor Store closes in September and if it is not reopened within eleven months the store would not be able to reopen as a business since it is not allowed in that zone. The Township Supervisors can make changes to the zoning now with the ordinance being redone. Mark and David stated they would re-evaluate the townships zoning and come to the next meeting to discuss with the Supervisors suggested changes to areas to allow small home business growth.
